- 1. Member agrees and understands that this membership is for 1 (one) year. Within the first year, Member may NOT cancel, suspend or "freeze" membership. _____ (Member initials)
- 2. Member agrees to respect the rules and regulations of Valley Golf Center, hereinafter referred to by VGC, as well as the rules provided by the United States Golf Association (USGA).
- 3. Kindly cooperate with VGC Team Members when they're enforcing rule(s). If there is a serious concern or dispute, please address it with a Manager.
- 4. There may be periods when the golf course is unavailable for play due to issues including, but not limited to, inclement weather and maintenance. Loss of play shall have \$0.00 value.
- 5. All Members are required to check-in at the Pro Shop with your VGC issued Member ID Card prior to playing their round of golf.
- 6. Notify the Pro Shop in advance, if you intend to play additional rounds.
- 7. Play the golf course holes in their proper order (1-9). Skipping holes and playing ahead of others is prohibited.
- 8. Play at a reasonable pace. If you are playing at a slower pace, let the group behind you play through to maintain a steady pace on the golf course.
- 9. Treat the golf course and others with respect. Repair divots & ball marks, and rake each bunker after use.
- 10. Wait for the group ahead of you to proceed to the next tee box prior to teeing off.
- 11. Damages to the property of VGC caused by misuse or neglect, e.g. taking divots or damaging putting greens, shall be cause for immediate termination of membership. Additionally, Member(s) hereby agree to pay for the repair and restoration of any, and all damage(s) caused by Member's misuse or the guest of a Member.
- 12. Members that are adult guardians are responsible for the actions of their minors, including their guests that are minors.
- 13. Membership is non-transferable and thus, may NOT be used by others. Any membership card used or attempting to be used by anyone other than the Member named on that card, will result in immediate termination of their membership.
- 14. You will be issued a Golf Course Membership Card upon registration for membership.
- 15. There is a \$5.00 fee to replace a lost or stolen membership card.
- 16. You may request a temporary freeze on your membership (up to 6 months). This will defer any charges for membership until you request reinstatement. You must return your membership card to the Pro Shop and sign a request form to freeze your membership. Memberships that exceed a 6 month "freeze" status will automatically be terminated.
- 17. We reserve the right to terminate membership for repeated violation(s) of any rule, term or condition stated herein.
- 18. Member may cancel and terminate membership by returning their membership card to the Pro Shop and signing a Request to Terminate form, *anytime after one (1) year from the date of this Agreement.*
- 19. Member understands that membership dues are paid in advance and are non-refundable.
