



## Golf Course Membership Agreement

**Your enjoyment and safety is our top priority. By signing below, you agree to abide by the following rules:**

1. Respect the rules and regulations of Valley Golf Center (VGC) and all of the rules associated with the game of golf.
2. Kindly cooperate with VGC Team Members when they're enforcing rule(s).
3. All members are required to check-in at the Pro Shop with your VGC issued Member ID Card prior to playing a round of golf.
4. Notify the Pro Shop if you intend to play additional rounds.
5. Play the golf course holes in their proper order (1-9). Skipping holes and playing ahead of others is prohibited.
6. Play at a reasonable pace. If you are playing at a slower pace than the group behind you, let them play through to maintain a steady pace on the golf course.
7. Treat the golf course and others with respect. Repair divots & ball marks, and rake each bunker after use.
8. Wait for the group ahead of you to clear the green, prior to teeing off.
9. Damages to property of VGC caused by misuse, including the facility, e.g. taking divots or damaging putting surfaces, shall be cause for immediate termination of membership. Additionally, member(s) hereby agree to pay for the repair and restoration of any and all damage(s) caused by misuse by a member or guest of a member.
10. Adult guardians are responsible for the actions of their minors, including their minor guests.
11. Any membership card used by anyone other than the member named on that card, will result in immediate termination of their membership.
12. We reserve the right to terminate membership for repeated violation(s) of any rule, term or condition stated herein.

### **Membership:**

- 1.) You will be issued a Golf Course Membership Card upon registration for membership.
- 2.) There is a \$5.00 fee to replace lost or stolen membership cards.
- 3.) You may place an indefinite freeze on your membership. This will defer any future charges for membership until you request reinstatement. You must return your membership card to the Pro Shop and sign a request form to freeze your membership.
- 4.) Member may cancel and terminate membership by returning their membership card to the Pro Shop and signing a Request to Terminate form.
- 5.) Member understands that membership dues are paid in advance, and are non-refundable.
